Registration for the Early Learning Assessment (ELA) Virtual Initial Training from August to November 2022 is open. The Early Learning Assessment (ELA) Virtual Initial Training is designed for early childhood professionals that will be observing, assessing, and scoring the ELA and have not been previously trained. This 10-hour Ohio Approved training requires participants to complete on-demand modules, attend three virtual learning Zoom sessions and pass the Content and Simulator Assessment at the end of the training.
