What is the Kindergarten Readiness Assessment Revised?

Teachers use the Kindergarten Readiness Assessment Revised (KRA-R) to get to know your child. The assessment measures your child's knowledge and abilities in social skills, language and literacy, mathematics and physical well-being and motor development. The KRA-R draws from your child's early experiences and gives you and the teacher information about the kinds of support your child needs to be most successful in the first year of school. The assessment aligns with Ohio's Early Learning and Development Standards.

How is the KRA-R Scored?

Teachers enter the score for each item into a secure online data system, so it stays private. The system calculates an overall score for your child.

What do the results mean?

Your child's KRA-R shows his or her level of readiness for learning in kindergarten. Performance on the KRA-R does not keep your child from staying in kindergarten. The assessment results and other information about your child simply help the school make decisions about what and how your child will be taught. The Language and Literacy area of the KRA-R can be used to meet the reading diagnostic assessment requirement of the Third Grade Reading Guarantee.

How and when is the Kindergarten Readiness Assessment Revised completed?

The KRA-R does not look like a test. Instead, the teacher observes your child's response when asked a question or when completing an activity. This may happen one-on-one or when your child is part of a group. Some items can be given on a tablet or computer.

Children receive support, when appropriate, to be able to show their skills and knowledge. Kindergarten teachers give the assessment to all children in their classrooms. A teacher may start the assessment up to two weeks before the school year begins. The assessment must end by Nov. 1.
