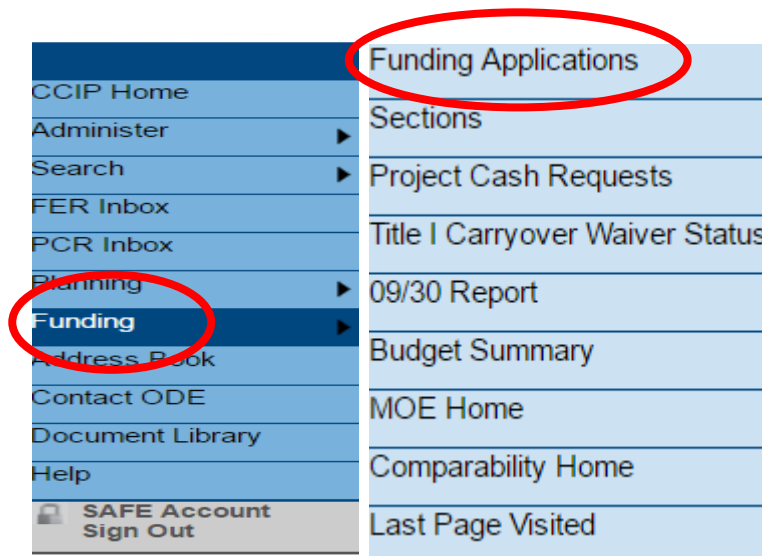


SUBSTANTIALLY APPROVED DATES (SAD)

The Substantially Approved Date is the date a grantee is legally allowed to begin obligating grant funds. The date the application is submitted in substantially approval form sets the grantees Substantially Approved Date.

View the initial SAD

Log into the CCIP. If necessary, go to Funding and Click on Funding Applications.



Select the appropriate year and “All Approved Applications”. The initial application is “Revision 0”. If the grantee has submitted revised applications, subsequent revisions will be show as Revision 1, 2, etc. To view the initial substantially approved date, click on the application name for Revision 0.

Grantees may begin obligating expenses in accordance with the revised budget once it is submitted in substantially approvable form – as of the revisions substantially approved date. Changes to the new budget are not retroactive to the original substantially approved date.
