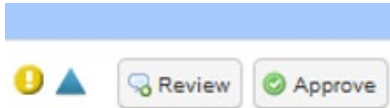




APPROVING CCP COURSES IN ODDEX

During the 45 days review window, a school district can approve or flag courses in ODDEX. When the payment responsibility was split between the district and the JVSD, during the review and approval stage the school should take the following steps to ensure the proper approval and assignment of payment responsibility.

Typically, there is an **Approve** button next to the course. However, that button is not available for split courses.

The district has to click a **Review** button next to the course and select an appropriate choice for payment responsibility. There is also a note at the bottom of the review screen that alerts the approver to the split course situation.

If your district is responsible – use this choice. Review flag moves the payment responsibility to the LEA placing this flag; does not impact funding beyond removing split.

If another district is responsible – use this choice. Review flag only stops funding for the portion of the split course assigned to the LEA that places this flag.

- This student is split between 2 or more LEAs based on reported enrollment data, but my LEA should pay for the entire CCP course instead of ODE splitting the costs.
- This student is split between 2 or more LEAs based on reported enrollment data, but my LEA should not pay for any of the CCP course.
- Student is enrolled in this district as of snapshot date; but also in another LEA who should be paying for this course
- Student is enrolled in this district as of snapshot date; but not in this course or dropped course before census date

- Beyond Full Time: Student beyond full time for CCP; total of CCP semester hours and HS grad credits x3 is greater than 30; course may not be fully funded.
- Student is enrolled in this LEA as of snapshot date; but course subject reported for student is not eligible for payment by the LEA under the CCP rules

If the district responsible for payment has “NONE” in **LEA Payment Responsibility** table **Payment by Reporting IRN** column, approval by placing a flag ENRL_SPLIT_BUT_MY_LEA_TO_PAY_ALL will not work. This has to be resolved through changes to the EMIS reporting for that student. Please refer to the **CCP - EMIS Coding** document.
