# School Bus Purchase Program Fiscal Year 2023

#### Introduction

Pupil transportation service is required for all Ohio students in kindergarten through eighth grade who live more than two miles from their schools.<sup>1</sup> Many school districts also provide transportation for students in grades 9-12 and for students who live between one and two miles from their schools. In fiscal year (FY) 2022, 13,994 Ohio school buses were assigned to daily routes in the state, transporting over 767,000 students. These buses ranged in model year from 1984 to 2022, with 40.8 percent of the school buses used regularly being more than eight years old. Considering the age of many buses and the accumulation of miles, the School Bus Purchase Program strives to maintain a high level of safety and vehicle reliability by decreasing the average age of buses across Ohio.

State funding for pupil transportation helps offset the costs of transporting public, chartered community and chartered nonpublic students to and from school. In the recently enacted state budget, the General Assembly appropriated more than \$537 million in FY22 and \$555 million in FY23 through school foundation funding to support the operating expenses of pupil transportation. However, these appropriations do not address the cost of procuring and replacing the buses needed to transport Ohio students. Based on a review of data reported by Ohio school districts, the average operating cost to transport a single student was \$1,077.09 in FY21. On average, schools spend \$2,969.21 annually on maintenance per bus. Over the last three years, the average purchase price of a new school bus in Ohio was \$95,000.<sup>2</sup>

In acknowledgment of the purchase price, ongoing maintenance for older buses, concerns around vehicle reliability and the need for new school buses, the state budget included a total of \$50 million for eligible districts to purchase school buses in fiscal years 2022 and 2023.<sup>3</sup>

## **School Bus Purchase Program Requirements**

Pursuant to <u>ORC 3317.071</u>, the Department developed the School Bus Purchase Program with the following goal in mind: Remove the oldest model year and highest mileage school buses used for regular route service in Ohio.

Under the program, the Ohio Department of Education will issue awards for eligible school districts to purchase one or more buses. Each bus purchased will require the school district to remove one of its older, qualifying buses (on the approved list provided by the Department) from regular daily service. If more than one bus is purchased, an equivalent number of qualifying buses shall be removed from regular service.

#### **Criteria for the Distribution of Funds**

The Department will make funding available to school districts based on the following:

- The percentage of buses in each district that is at least eight years old with mileage greater than 96,000. Districts will be ranked in eligibility priority based upon the number of qualifying buses as a percentage of their total fleet in regular route service.
- School districts not awarded funding through this grant in FY22.
- School districts will be awarded based on the following calculation: \$95,000 multiplied by the school district's FY23 State Share Percentage, with each awarded district receiving at least \$45,000.<sup>4</sup>
- After awarding each district on the eligibility list with one bus replacement, the Department will award a second allocation for bus purchase starting again with the highest-ranked district. This will continue until all funds are exhausted. Districts receiving more than one new bus allocation must replace an equivalent number of old buses. For example, a district receiving two bus replacements must purchase at least two buses and remove from regular service at least two old buses.

## **Timeline and Distribution of Funds**

Districts awarded school bus purchase funds will be notified by the Department on or before Dec. 1, 2022. Districts that wish to accept the award will need to return the signed assurances document and a bus quote to the Department by June 1, 2023. If a district only accepts the funding for a partial award amount the allocation will be reduced accordingly.

Funding will be available beginning Dec. 1, 2022, to districts that have accepted an award amount. The program will NOT provide reimbursement for purchases made before Nov. 1, 2022. Schools are required to obligate funds by June 30, 2023, and liquidate funds by Sept. 30, 2023.

## **Grant Assurances and Requirements**

School districts receiving funds under the School Bus Purchase Program must agree to the following:

- 1. Funds will be used to support the purchase of at least one school bus for each funding unit allocated after the date of the school district's award letter. Funds are restricted for this purpose only;
- 2. Schools are required to obligate funds by June 30, 2023, and liquidate funds by Sept. 30, 2023.
- 3. Districts will provide documentation to the Ohio Department of Education verifying that the subsidy amount was used to purchase one or more school buses as determined by the funding allocation during the allowable timeframe. A receipt of sale and/or purchase documents will be submitted as verification. Verification must be submitted by Sept. 30, 2023, in a manner prescribed by the Ohio Department of Education;<sup>5</sup>
- 4. Districts will remove at least one school bus from regular service for each bus purchased; and
- 5. Districts will return funds provided under the program to the Ohio Department of Education if the school district fails to purchase the required bus(es) during the allowable timeframe.
