Executive Summary

State law requires the Ohio Department of Education and Workforce to conduct an annual audit of each city, local, and exempted village school district regarding its compliance with the requirements for sexually transmitted infection (venereal disease) education. This document consists of the audit findings from Ohio school districts that self-reported information regarding sexually transmitted infection education and course materials used during the 2023-2024 school year. Compliance is based on the responses to Questions 1, 2, and 3 (see below).

The reporting window for the 2023-2024 audit was open March 18-Aug. 1, 2024. The Department sent email notifications and reminders regarding the audit reporting requirements and deadlines. The Department also notified districts through Department alerts; the Department's weekly newsletter, EdConnection; and phone calls. Technical support was provided via phone, email, and virtual meetups to assist districts with the process during the audit window.

The findings show that:

- 100% of districts completed and submitted the information for the audit.
- The vast majority of districts (99.5%) are Overall Compliant. The three districts with an "Overall Non-Compliant" status (Jefferson Township Local, Ridgewood Local, Washington Local) received a phone call and a noncompliance letter from the Department stating the reason(s) for non-compliance.

District Reporting Status

Districts were placed into one of three categories based on reporting status.

Completed – The district answered all questions and submitted the information in the system.

Not started - The district did not start the audit.

In Progress – The district did not completely answer questions or did not submit the information.

AUDIT QUESTION 1

AUDIT QUESTION 2

Pursuant to Ohio Revised Code (ORC) 3313.60, did the district offer venereal disease and sexual education instruction during school year 2023-2024?

- If yes, please provide the name of any organization or program that provided venereal disease and sexual education instructional materials.
- If no, please explain your answer.

Note: School districts and schools are not required to upload documents as part of the audit. Any uploaded documents will not be considered for compliance.

AUDIT QUESTION 3

Did the district offer course material and instruction in venereal disease and sexual education courses, pursuant to Ohio Revised Code 3313.6011, that do all of the following?

- Stress that students should abstain from sexual activity until after marriage.
- Teach the potential physical, psychological, emotional, and social side effects of participating in sexual activity outside of marriage.
- Teach that conceiving children out of wedlock is likely to have harmful consequences for the child, the child's parents, and society.
- Stress that sexually transmitted diseases are serious possible hazards of sexual activity.



- Advise students of the laws pertaining to the financial responsibility of parents to children born out of wedlock.
- Advise students of the circumstances under which it is criminal to have sexual contact with a person under the age of sixteen pursuant to section 2907.04 of the Ohio Revised Code.
- Emphasize adoption as an option for unintended pregnancies.
