
Why Materials Matter for Ohio Students

In Ohio, we believe that access to high-quality instructional materials is critical for equity and ensures that each student acquires the knowledge and skills to be successful through a standards-aligned instructional foundation. Research has found that stronger student learning occurs when educators engage in job-embedded, sustained professional learning that is grounded in quality content. High-quality instructional materials act as a common language and platform for engaging all partners in students' educational experience.

Access to Quality Matters for Student Success

At the Ohio Department of Education, we want to support teachers to ensure they have access to grade-level appropriate materials to meet the needs of all students.



Research has shown that when students have inconsistent access to high-quality content, there is a significant impact on their learning. The average student spends approximately 75% of their available school hours on assignments that are not high quality. This is particularly significant for students of color and students living in poverty who have less access to high-quality, standards-aligned materials than their peers.
