Assessment Overview

Acadience® Reading as a benchmark and progress monitoring assessment is well-positioned to support Ohio educators in screening students for reading difficulties, including dyslexia, as well as identifying students who need additional instructional support to ensure outcomes are improved.

Acadience Reading is designed to be an efficient, cost-effective tool used to help educators make decisions about instruction, to provide support early, and to prevent the occurrence of later reading difficulties.

Acadience Reading K–6 is a set of measures that serve as key indicators of essential early reading skills including phonemic awareness, letter recognition, alphabetic principle and early phonics, accuracy and fluency in reading connected text, comprehension, vocabulary/oral language. Acadience Reading K–6 can be administered digitally via the Acadience Learning Online (ALO) platform or manually via paper/pencil. The assessment is administered individually with the exception of Maze which can be administered individually or in a group.

The primary interpretive framework for Acadience Reading K–6 is the benchmarks and cut-points for risk. Acadience Reading K–6 provides two types of scores at each benchmark assessment period: (a) a raw score for each individual measure and (b) a composite score (e.g., Reading Composite Score.) Acadience Reading K–6 Benchmarks and Cut Points for Risk indicate a level of skill at which the student is likely to achieve the next benchmark or reading outcome. Benchmarks for Acadience Reading K–6 are based on research that examines the predictive validity of a score on a measure at a particular point in time, compared to later Acadience Reading K–6 measures and external outcome assessments. If a student achieves the Benchmark, and if the student receives effective instruction from a core curriculum, then the odds are in favor of that student achieving later reading outcomes. If a student does not achieve the Benchmark and are found to score Below Benchmark or Well Below Benchmark, the odds are not in favor of the student achieving later reading outcomes without supplemental instructional support or intensive intervention.

To support educational systems in the use of Acadience assessments, Acadience Learning provides ongoing implementation support for educators and schools who are new to the Acadience assessments and/or data management services or to those educators who wish to deepen their understanding of Acadience assessment for use as part of the comprehensive assessment system.
