For students in Kindergarten, we recommend scheduling three 20-minute sessions per subject; and for students in grade 1, we recommend two 20- to 30-minute sessions per subject. On average, students in these grades take 25–35 minutes of active time to complete the Diagnostic for each subject, with the majority completing in less than 45 minutes. For students in grades 2–5, we

Frequency

Students may be given the i-Ready Diagnostic up to three times each school year, with 12–18 weeks of instruction between assessments.

Use by Teachers

The detailed and precise measurement delivers immediate reports at the district, school, class, and student levels. The reports identify the instructional needs of students and provide explicit guidance for differentiation of instruction through i Ready's downloadable and online resources. Students receive a grade-level placement score overall, as well as by domain.
