Transportation Notification - Per Ohio law ORC 3327.01, Ohio community schools must share their start and end times with all districts in which their students reside by April 1 to ensure that transportation services are available in the upcoming school year.

Ohio to receive \$48 million kindergarten readiness grant

The Ohio Department of Job and Family Services (ODJFS)



recently announced that it will receive \$48 million in federal funding over a three-year period in support of efforts to help the Buckeye State's youngest learners. The Preschool Development Grant—Birth to Five was awarded by the U.S. Department of Health and Human Services.

It will support initiatives aimed at: improving access to early childhood care and education; expanding childcare for special populations of students (English learners, special needs and homeless); creating sustainable funding for early childhood education programs; and, more.

ODJFS will coordinate with the departments of: Education; Mental Health and Addiction Services; Medicaid; and Developmental Disabilities to administer grant-funded initiatives.

135th General Assembly off to a busy start

Ohio's 135th two-year legislative session is off to a busy start and the Statehouse is buzzing with activity. The two issues of most interest to K-12 education stakeholders are: the proposed overhaul of the Ohio Department of Education (ODE) and realignment of State Board of Education responsibilities; and the state biennial budget bill to provide funding for the next two fiscal years (beginning July 1, 2023) and implement a diverse slate of public policies.

The proposed ODE/State Board changes considered by the legislature in the year-end "lame duck" session (S.B. 178; 134th General Assembly) has been reintroduced in the new 135th General Assembly as S.B. 1. As its number suggests, it's a top Senate priority slated for passage in the upper chamber independent and in advance of the budget bill.

As previously reported, the proposal calls for ODE to be renamed as the Ohio Department of Education and Workforce (DEW) under the leadership of a director appointed by the governor (with advice and consent of the Senate). The new cabinet-level agency would have two divisions – the Division of Primary and Secondary Education and the Division of Career-Technical Education – each with its own deputy director. Most of the powers and duties of the State Board of Education

and the superintendent of public instruction would transfer to DEW.

There are, of course, both proponents and opponents who are sure to engage in the legislative process as S.B. 1 is considered and debated in the Senate and House of Representatives. Among the supporters is Governor Mike DeWine. He recently presented his budget proposal – which does not assume adoption of the ODE/State Board changes -- to the legislature.

The governor's two-year budget proposal calls for continued phase-in of the Cupp-Patterson K-12 education funding plan (first provided for in the last state biennial budget) and



expansion of Ohio's private school vouchers.

The DeWine Administration proposes decreases in ODE's overall budget – by 5.6% in the first year (from \$16.02 billion to \$15.13 billion) and 10.4% in the second (to \$13.56 billion) – against the backdrop of anticipated reduction of federal funds.

A few highlights of the plan include:

- Additional \$3,000 in funding for economically disadvantaged (high quality) charter school students;
- Increase in charter school facilities from \$500 to \$1,000 per pupil;
- State-funded Science of Reading curriculum and implementation support;
- Expansion of the School Safety Center; and,
- Funding for school resource officers.

It was presented to the State Board of Education at its February meeting by Interim State Superintendent of Public Instruction Dr. Stephanie Siddens.

All-Ohio United States Armed Forces Career Commitment Celebration

Students in grades 11 and 12 who have committed to military service – attending a service academy in the fall, accepting a Reserve Officer Training Corp (ROTC) scholarship, or enlisting for service as active duty, reserves or National Guard – can register to attend the March 7 All-Ohio United States Armed Forces Career Commitment Celebration. Ohio Literacy Academy returns

The Ohio Department of Education's Literacy Academy returns in person June 8 in Columbus. The sixth annual Literacy Academy will provide professional learning to support the use of evidencebased language and literacy practices. Ohio districts, schools, and early childhood education programs working to raise literacy achievement are encouraged to participate in this free program. Registration will open late spring. Young Women's Summer Institute

The Young Women's Summer Institute is a week-long program sponsored by the Ohio Supercomputer Center (OSC) for Ohio middle school girls. Designed to provide hands-on experience with computers, math, science, and engineering, YWSI encourages girls to develop an interest in these subjects by allowing them to work on practical, interesting scientific problems using the latest computer technology.

Who is eligible to apply? Ohio female residents in grades 6 & 7 (in the 2022-2023 school year) and K-12 science and math teachers.

The program is scheduled for Sunday, July 9 to Saturday, July 15, 2023 at the Ohio Supercomputer Center in Columbus. Learn more online here.

New lawsuits filed over school LGBTQ policies

Lawsuits challenging school district LGBTQ student policies continue to be filed, including one by parents against the Hilliard City School District located in a Columbus area suburb. It accuses "activist teachers" of soliciting information from students about sexual behaviors and attitudes without parent consent and objects to some teachers wearing so-called "I'm Here" badges to express their support for LGBTQ students.

The union representing Hilliard teachers has defended the badges in a statement referring to them as "visible symbols of support to their students who may need it," citing higher-than-average rates of suicide among LGBTQ youth.

A group of parents has also filed a lawsuit against the Bethel Local School District, located in western Ohio, for allowing an unnamed ninth-grade transgender girl to use the girls' bathroom. The American Civil Liberties Union of Ohio has filed a motion to intervene, arguing that barring the transgender student

from using the girls' bathroom "would impair her ability to fully participate in school life."

A lawsuit filed last year by a teacher who claims she was forced to resign from the Jackson Local School District in Stark County for refusing to use pronouns inconsistent with students' sex at birth is ongoing.

It is important for each school to work with legal counsel regarding policies and practices.
