Introduction and General Information

Under Ohio law public school districts and community schools may request reimbursement for costs exceeding the threshold to educate students with disabilities in certain funding categories for the 2021-2022 school year. For traditional public school districts, students generally live in and are educated by that district. However, if another school district or joint vocational school educates a student and files excess cost against the resident school district, the resident district may request catastrophic cost reimbursement of the excess cost. In addition, traditional public school districts enrolling nonresident students with disabilities for whom tuition and excess costs could not be charged¹ may request catastrophic cost reimbursement for those students.

Catastrophic aid is available as a supplemental payment to districts, joint vocational schools and community schools for special education students in funding categories 2-6. This reimbursement is available to the financially responsible district or school for any student in categories 2, 3, 4 or 5 whose educational and related expenses exceeded \$27,375, and for any student in category 6 whose expenses exceeded \$32,850 in the prior school year.

Getting Started

The superintendent and treasurer have immediate access to the program, staff performing the role of Data Entry – Catastrophic Cost must be assigned that role by the organization’s Ohio Educational Directory System (OEDS) administrator.

Completing the Calculation Spreadsheet

A district may include costs for a student—including federal funds—but no legal costs in a special education catastrophic cost submission². The *Calculation Spreadsheet* provides districts with a tool to determine educational expenses for specific students without uploading individual expense documentation.

The Calculation Spreadsheet is a multi-tab document developed to assist districts in capturing total educational costs for students. Tabs are configured for ease of use. After entering the SSIDs on the appropriate tab, the SSIDs will populate on subsequent tabs. **Additional SSIDs can be entered beginning at line 1001 for students with multiple expenses.** Fields in yellow are editable with applicable data. Fields in gray are not editable. Each tab and the subsequent fields are explained below.

SSIDs

This tab is the entry point for educational costs claimed as catastrophic costs.

Report “FTES003” from the Data Collector can be used to obtain FTEs for students educated in the district. Report “TUIT-002” and “TUIT-004” can be used to collect FTEs for resident students who are court or foster placed (tuition students).

The IE Code from the pull-down menu is under the history SSID in ODDEX.

B1: Enter district name

B2: Enter district IRN (six-digit number)

Column A: Enter SSID.

Column B: Enter the FTE the student was a resident at the district. This should match the FTE detail report.

Column C: Enter IE Code from the pull-down menu. Excess Cost students and any student where the IE code is not 15, 14 or 13 should be entered as IE16.

IE Code is an Outcome ID Element recorded on the Student Special Education (GE) Record. The IE Code data on the spreadsheet is used to capture the amount of time spent in regular education classrooms:

IE16: 0% regular education classroom time - Public Separate School Student with a disability receiving special education and special education services, at public expense, for greater than 50% of the school day in public separate schools. This may include:

- Students with disabilities attending county boards of developmental disabilities.
- Ohio School for the Deaf, Ohio State School for the Blind (if the student does not live there during the week).
- Public day schools for students with disabilities.
- Public day schools for students with disabilities for a portion of the school day (greater than 50%) and in regular school buildings the remainder of the school day.

IE15: 40% regular education classroom time - Students with a disability receiving special education and special education services outside the regular classroom for more than 60% of the school day. Students who receive education programs in public or private separate day or residential facilities should NOT be reported with this code. This category may include:

- Self-contained special classrooms with part-time instruction in a regular class.
- Self-contained special classrooms with full-time special education instruction on a regular school campus.
- Students with disabilities whose parent(s) have opted for home schooling and who receive special education at public expense.

IE14: 79% regular education classroom time - Special education outside the regular classroom at least 21% of the day and no more than 60% of the day. This may include placement in:

- Resource rooms with special education and special education services provided within the resource room.
- Resource rooms with part-time instruction in a regular class.

IE13: 100% regular education classroom time - Student with a disability receiving special education and special education services outside the regular classroom for less than 21% of the school day. This may include placement in:

- Regular classes with special education and special education services provided within regular classes.
- Regular classes with special education and special education services provided outside regular classes.
- Regular classes with special education services provided in resource rooms.

Column D

Column D Will automatically populate with maximum percentage of time associated with the IE Code entered.

Special Education Teachers

Special education teachers provide educational opportunities as part of a self-contained classroom, support in a resource room or in collaboration with a general education teacher.

Special education teacher salaries include the amounts paid to district personnel for the district's instructional program. If the special education teacher is not an employee of the school district, the amount paid to non-district employees can be reported in column O.

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Column B: Enter teacher first name as reported in EMIS for the 2021-2022 school year.

Column C: Enter teacher last name as reported in EMIS for the 2021-2022 school year.

Column D: Enter teacher wages as reported per the Earnings Register for the 2021-2022 school year. (Example 9/1/2020 – 8/31/2021.)

Column E: Retirement (14 percent) will automatically populate (calculation: column D x 0.14).

Column F: Enter pick-up on pick-up retirement, if applicable.

Column G: Medicare will automatically populate at 1.45% percent (calculation: column D x 0.0145)

- Cell H2: Enter district workers' compensation rate as a percentage. This percentage will be used in all subsequent tabs where a workers' compensation rate calculation is needed.

Column H: Workers' compensation will automatically populate (calculation: column D x H2).

Column I:

- Option 1 - Enter district's total cost for health, dental and vision insurance for the employee for the 2021-2022 school year and skip to column L.
- Option 2: Enter district's total cost for health insurance for the employee for the 2021-2022 school year, and enter other insurance types in columns J and K.

Column J: If dental insurance was not included in column I for the 2021-2022 school year, enter district's total cost for dental insurance for the employee.

Column K: If vision insurance was not included in column I for the 2021-2022 school year, enter district's total costs for vision insurance for the employee.

Column L: Enter district's total cost for life insurance for the employee for the 2021-2022 school year.

Column M: If other costs for employee compensation are claimed, enter "Other Description" (for example, mileage, bonus, etc.).

Column N: If other costs for employee compensation are claimed, enter "Other Cost."

Column O: If student is educated through an educational service center or cooperative (co-op), enter cost for the program.

Column P: Total Cost will automatically populate (the cost entered in column O or sum of columns D, E, F, G, H, I, J, K, L, N).

Column Q: Enter the total FTEs assigned to the special education teacher or educational program. For this calculation, divide the student count by the in-classroom periods. For example, in the case of a high school teacher:

- 1st period – five students; 2nd period – four students; 3rd period – three students; 4th period – planning period; 5th period – four students; 6th period – four students; and 7th period – three students.
- Total student count: 23 students/six in-classroom periods = 3.83 FTEs.

Column R: Enter percentage of time the student was assigned to the teacher. For this calculation, divide the student's total enrolled hours by the time assigned to the teacher. For example:

- A student has a teacher for 45 minutes per day and classes are in session for 180 days.
- 180 multiplied by 45 equals 8100 minutes, divided by 60 minutes/hour = 135.
- The student is thus assigned to the teacher for 135 hours per year.
- Calculation: $135/1080 = 12.5\%$ of time.

Column S: Cost per student will automatically populate (calculation: column P/Q * R).

Instructional Supplies

This expense is limited to supplies and materials appropriate for providing special education and related services to a specific student.

The per capita rate will automatically populate. Only student specific costs need to be entered.

If contracted education program costs are claimed, no instructional supplies cost will be calculated.

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Cell B3: The per capita rate is displayed.

Column B: If claiming student specific costs, enter item description.

Column C: If claiming student specific costs, enter vendor name.

Column D: If claiming student specific costs, enter purchase order number.

Column E: If claiming student specific costs, enter amount paid.

Column F: Annualized Cost will automatically populate (calculation: amount listed in column B or F).

Instructional Equipment

This expense is limited to instructional equipment that provides special education and related services to a specific student.

The per capita rate will automatically populate. Only student specific costs need to be entered.

If contracted education program costs are claimed, no instructional supplies cost will be calculated.

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Cell B3: The per capita rate is displayed.

Column B: If claiming student specific costs, enter item description.

Column C: If claiming student specific costs, enter vendor name.

Column D: If claiming student specific costs, enter purchase order number.

Column E: If claiming student specific costs, enter amount paid.

Column F: Annualized Cost will automatically populate (calculation: amount listed in column B or F).

Operations Support Costs

Operations support costs should include operation and maintenance of plant as well as non-instructional food service. The operations support costs should not include transportation. The calculation will automatically populate in cell B3.

Operation and plant maintenance and non-instructional food service per capita will automatically populate. Only alternative operations support costs will need to be entered. Please contact the area coordinator if an alternative calculation is used.

If contracted education program costs are claimed, no operations support costs will be calculated.

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Cell B3: Operation and plant maintenance and non-instructional food service per capita is displayed.

Column B (Alternative Operations Support Costs): Districts that would like to provide alternative operations support costs for all students should contact their [area coordinator](#).

Transportation

Eligibility for special education transportation is not automatic and must be listed as a service recommendation in the student IEP.

There are four choices to file transportation:

Option 1: Use the alternative calculation for regular education.

Option 2: Use the alternative calculation for special education.

Option 3: Use student specific costs.

Option 4: No transportation costs.

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Column B: If the student is provided regular student transportation, enter alternative calculation for regular transportation cost as displayed in cell C5.

Column C: If the student is provided special education transportation, enter the alternative calculation for special education transportation cost as displayed in cell C6. Special education transportation cost is determined by special education ridership at or greater than 50 percent of the assigned bus

Column D: If special education transportation is claimed, enter the bus number to which the student was assigned.

Column E: If special education transportation is claimed, enter the total number of riders assigned to the bus number.

Column F: If special education transportation is claimed, enter the total number of special education riders assigned to the bus number.

Column G: If student specific transportation is claimed, enter the student specific transportation costs including transportation aides.

Column H: Total transportation cost for the student is displayed.

Contracted Education Programs

Contracted education services address student educational needs. Unlike student specific services entered as related services, contracted programs typically encumber the entire program cost.

Related services are subdivided into additional categories. "Services" means those of a developmental, corrective and supportive nature including speech-language pathology and audiology services; psychological services; physical and occupational therapy; teacher aides; recreation, including therapeutic recreation; social work services; counseling services, including rehabilitation counseling orientation and mobility services; and medical services [for diagnostic and evaluation purposes only] that help a student with a disability benefit from special education. This includes early identification and assessment of disabling conditions.

This should be used only for an educational program, not a contracted related service.

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Column B: Enter vendor name providing the contracted education program.

Column C: Enter description of program provided (examples: Positive Education Program, Life skills and Education for Students with Autism and other Pervasive Behavioral Challenges [LEAP] Program).

Column D: Enter purchase order number.

Column E: Enter amount paid.

Column F: If excess cost certification amount is used for contracted education program cost, enter the excess cost certification amount (cost to educate) line 11 on the excess cost certification.

Column G: Total cost will automatically populate (calculation: amount listed in columns E and F).

Composite Rate

The composite hourly rate is available for districts that have difficulty identifying multiple staff members that have provided services to a student.

A district may use a composite rate or actual rate for staff members but not a combination of both.

The composite rate calculation can be found for the following:

- Occupational Therapy Staff
- Physical Therapy Staff
- Therapeutic Therapy Staff
- Life Skills
- Psychological and Social Services

Each composite rate calculation is set up in the same manner:

Student Hours: Enter the number of hours used by most students within the district.

Average Wages: Will automatically populate after completing the employee section of the category.

Average Benefits: Will automatically populate after completing the employee section of the category.

Average Total: Will automatically populate after completing the employee section of the category.

FTE Total: Will automatically populate after completing the Staff FTE.

Base Hourly Rate: Will automatically populate after completing the employee section of the category.

First Name: Enter the first name of the staff member to be included in the composite rate of the category.

Last Name: Enter the last name of the staff member to be included in the composite rate of the category.

FTE: Enter the total FTEs assigned to the provider.

Wages: The wages for the staff member to be included in the composite rate.

Benefits: The total benefits (health insurance, dental insurance, vision insurance and life insurance) for the staff member to be included in the composite rate.

Total: Will automatically populate.

Occupational Therapy

Occupational therapy (OT) is a related service under Part B of Individuals with Disabilities Education Act (IDEA). Eligibility for occupational therapy is not automatic and must be recommended in the student IEP.

If the composite rate was calculated for this service, it will be displayed in D2. If the composite rate is used, the only additional column requiring data is Hours of Service (column R).

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Column B: If employee salary will be used, enter staff member's first name as reported in EMIS for the 2021-2022 school year.

Column C: Enter staff member's last name as reported in EMIS for the 2021-2022 school year.

Column D: Enter staff member's wages as reported in EMIS for the 2021-2022 school year.

Column E: Retirement (14 percent) will automatically populate (calculation: column F x 0.14).

Column F: Enter pick-up on pick-up retirement, if applicable.

Column G: Medicare will automatically populate at 1.45 percent (calculation: column F x 0.0145).

Column H: Workers' compensation will automatically populate (calculation: H2 on special education tab x column F).

Column I:

- Option 1: Enter district's total cost for health, dental and vision insurance and skip to column L.
- Option 2: Enter district's total cost for health insurance, enter other insurance types in columns L and M.

Column J: If dental insurance was not included in column I, enter district's total cost for dental insurance.

Column K: If vision insurance was not included in column I, enter district total cost for dental.

Column L: Enter district total cost for life insurance.

Column M: If other cost for employee compensation is claimed, enter "Other Description."

Column N: If other cost for employee compensation is claimed, enter "Other Cost."

Column O: Will automatically populate.

Column P: Enter total hours in school year.

Column Q: Will automatically populate.

Column R: Enter number of hours recommended in IEP.

Column S: Enter vendor name.

Column T: Enter purchase order number.

Column U: Enter amount paid.

Column V: Actual cost will automatically populate.

Physical Therapy

Physical Therapy (PT) is a related service under Part B of IDEA. Eligibility for physical therapy is not automatic and must be recommended in the student IEP.

If the composite rate was calculated for this service, it will be displayed in D2. If the composite rate is used, the only additional column requiring data is Hours of Service (column R).

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Column B: If employee salary will be used, enter staff member's first name as reported in EMIS for the 2021-2022 school year.

Column C: Enter staff member's last name as reported in EMIS for the 2021-2022 school year.

Column D: Enter staff member's wages as reported in EMIS for the 2021-2022 school year.

Column E: Retirement (14 percent) will automatically populate (calculation: column F x 0.14).

Column F: Enter pick-up on pick-up retirement, if applicable.

Column G: Medicare will automatically populate at 1.45 percent (calculation: column F x 0.0145).

Column H: Workers' compensation will automatically populate (calculation: H2 on special education tab x column F).

Column I:

- Option 1: Enter district's total cost for health, dental and vision insurance and skip to column L.
- Option 2: Enter district's total cost for health insurance, enter other insurance types in columns L and M.

Therapeutic Therapy

Therapeutic therapy is intervention not described as OT or PT. Eligibility for therapeutic therapy is not automatic and must be recommended in the student IEP.

If the composite rate was calculated for this service, it will be displayed in D2. If the composite rate is used, the only additional column requiring data is Hours of Service (column R).

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Column B: If employee salary will be used, enter staff member's first name as reported in EMIS for the 2021-2022 school year.

Column C: Enter staff member's last name as reported in EMIS for the 2021-2022 school year.

Column D: Enter staff member's wages as reported in EMIS for the 2021-2022 school year.

Column E: Retirement (14 percent) will automatically populate (calculation: column F x 0.14).

Column F: Enter pick-up on pick-up retirement, if applicable.

Column G: Medicare will automatically populate at 1.45 percent (calculation: column F x 0.0145).

Column H: Workers' compensation will automatically populate (calculation: H2 on special education tab x column F).

Column I:

- Option 1: Enter district's total cost for health, dental and vision insurance and skip to column L.

Life Skills

Life skills services assist students in achieving independence. Life skills include a wide range of practical and functional living skills that prepare students to live in their communities, engage in the workplace and engage in self-care.

If the composite rate was calculated for this service, it will be displayed in D2. If the composite rate is used, the only additional column requiring data is Hours of Service (column R).

Column A: Student SSID will automatically populate for students entered on the SSID tab listed in columns A4 to A1000.

Column B: If employee salary will be used, enter staff member's first name as reported in EMIS for the 2021-2022 school year.

Column C: Enter staff member's last name as reported in EMIS for the 2021-2022 school year.

Column D: Enter staff member's wages as reported in EMIS for the 2021-2022 school year.

Column E: Retirement (14 percent) will automatically populate (calculation: column F x 0.14).

Column F: Enter pick-up on pick-up retirement, if applicable.

Column G: Medicare will automatically populate at 1.45 percent (calculation: column F x 0.0145).

Column H: Workers' compensation will automatically populate (calculation: H2 on special education tab x column F).

Column I:

- Option 1: Enter district's total cost for health, dental and vision insurance and skip to column L.
- Option 2: Enter district's total cost for health insurance, enter other insurance types in columns L and M.

Column J: If dental insurance was not included in column K, enter district's total cost for dental insurance.

Column K: If vision insurance was not included in column K, enter district's total cost for vision insurance.

Column L: Enter district's total cost for life insurance.

Column M: If other cost for employee compensation is claimed, enter "Other Description."

Column N: If other cost for employee compensation is claimed, enter "Other Cost."

Column P: Enter total hours in school year.

Column Q: Will automatically populate.

Extended School Day/Year Programs

Expenses for extended day programs and extended school year programs are limited to the daily rate for services supporting a student with a disability—as documented under IDEA—to maintain academic, social/behavioral, communication or other skills as part of the IEP or Section 504 accommodation plan. This includes transportation expenses beyond the typical school year. Should an extended school year program continue beyond the fiscal year, expenses should include those in the fiscal year in which the student's extended school year program started. Costs should be handled this way because a student may not return the following year, and because in the event a student is only reported for a few weeks in the next fiscal year, the threshold to meet reimbursement may not be reached.

These costs are associated with the extended portion of the school year.

Column N: Enter transportation cost (if not included as part of the transportation tab).

Column O: Enter the occupational therapy cost (if not included as part of the occupational therapy tab).

Column P: Enter the physical therapy cost (if not included as part of the physical therapy tab).

Column Q: Enter the therapeutic therapy cost (if not included as part of the therapeutic therapy tab).

Column R: Enter the life skills cost (if not included as part of the life skills tab).

Column S: Enter the psychological and social services cost (if not included as part of the psychological and social services tab).

Column T: Enter the speech and hearing cost (if not included as part of the speech and hearing tab).

Column U: Enter the health services cost (if not included as part of the health services tab).

Column V: Enter the tutor cost (if not included as part of the tutor tab).

Third-party consultation provides support, advice and consultation to the district.

Legal service cost cannot be claimed.

Cost to Educate

The Cost to Educate tab will sum the costs entered on the previous tabs. The cost to educate tab will need to be copied and pasted to the Upload Spreadsheet.

Select the lines and columns containing data, copy (CTRL+C), paste special (CTRL+ALT+V) and select values to the Upload Spreadsheet.

Staff Support Costs

This line item will populate automatically with the district's general fund per capita amount after this spreadsheet is loaded. If there is supporting documentation, districts may override the pre-populated amount and include building-specific staff support costs. Staff support expenses include function codes 2200-2290 with the exceptions of 2211, 2221 and 2231. Itemization of staff support costs is available to claim, but the calculation and explanation of these expenses must support the itemized costs.

Pupil Support Costs

Pupil support costs should not be claimed if related services (other than transportation) or contracted educational program costs are claimed. Pupil support expenditures per pupil include expenses associated with services other than instruction that enhance developmental processes. These cover a range of activities such as student counseling, psychological services, health services and social services.

When a district uploads an SSID into the Catastrophic Cost system, the system creates an application. The system checks for three conditions before the application is listed as Started:

1. Is the SSID in EMIS?
2. Is there a valid disability condition associated with the SSID? (categories 2-6)
3. Is the resident district IRN associated with the SSID in EMIS?

If the answer to any of the above questions is no, the application will be assigned Data Issue status and a fatal flag(s) will be attached to the application describing the data issue(s) found:



- SSID not found in EMIS (this flag cannot be removed)
- Valid disability condition not found in EMIS
- Resident district not associated with SSID in EMIS

All applications with Data Issue status should be withdrawn or corrected, then started again. Districts and area coordinators can withdraw an application that has a data issue. However, only area coordinators can correct an application with a data issue and change its status to Started.

No application should remain in Data Issue status. Either withdraw the application or ask for help from the [area coordinator](#) to place the application into Started status. The district will **not** be paid catastrophic costs for any student application remaining in Data Issue status.

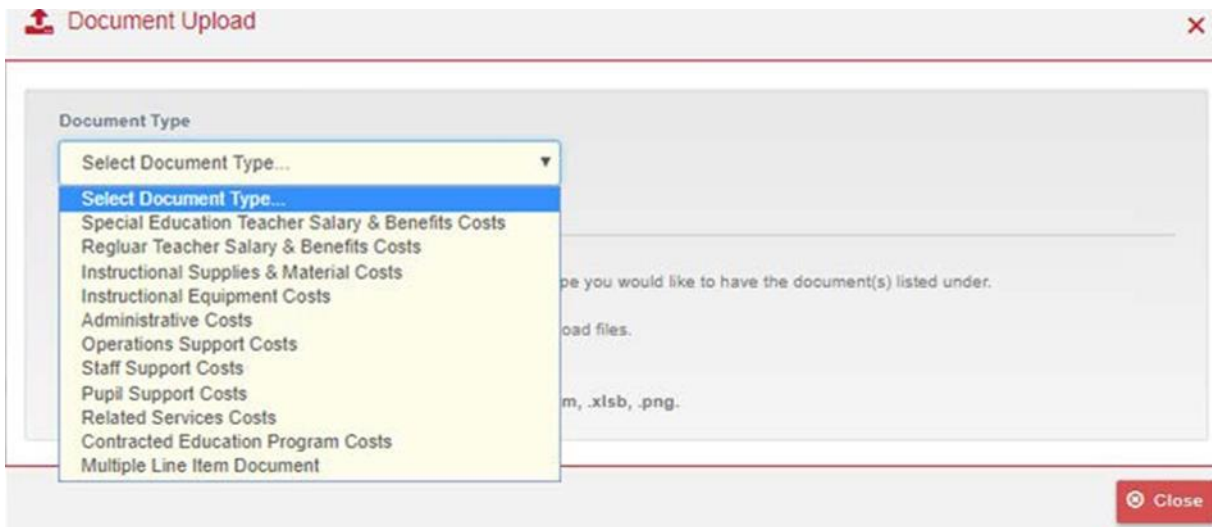

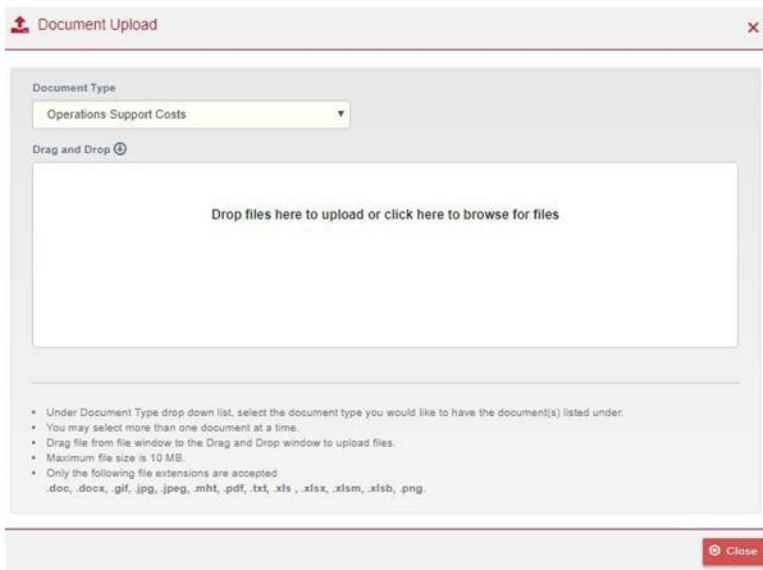

Treasurer and Superintendent Roles

A district cannot change applications in Submitted status.

When an application enters Submitted status, the Department will send it to the area coordinator for review. During the review, the area coordinator can take the following actions:

- Approve the catastrophic cost application, which will change its status to Approved.
- Put the application on hold while awaiting more information (Status = ODE on Hold).
- Return the application to the district for correction. The status will show as Correction Needed and a flag will indicate what requires correction.

Flags

The system will check student eligibility automatically based on the information provided.
