The following persons are eligible for an AREI/IPTI subsidy payment. Please indicate your eligibility.

**I AM AN HONORABLY DISCHARGED VETERAN OF THE UNITED STATES ARMED FORCES.** To qualify for the subsidy, the following documentation is required:

- A copy of your DD Form 214 or NGB-22, as issued by the United States Department of Defense.

**I AM OR WAS THE SPOUSE/SURVIVING SPOUSE OF AN HONORABLY DISCHARGED VETERAN OF THE UNITED STATES ARMED FORCES.** To qualify for the subsidy, the following documentation is required:

- A copy of the veteran's DD Form 214 or NGB-22, as issued by the United States Department of Defense.
- A copy of a valid marriage license or certificate verifying that you were lawfully married to the veteran at the time of his/her discharge.

**I AM A CURRENT MEMBER OF THE UNITED STATES ARMED FORCES.** To qualify for the subsidy, one of the following documentation is required:

- A copy of your military orders, military ID, DD Form 214, or NGB-22, as issued by the United States Department of Defense.

**I AM THE SPOUSE OF A CURRENT MEMBER OF THE UNITED STATES ARMED FORCES.** To qualify for the subsidy, the following documentation is required:

- One of the following: A copy of the military service member's military orders, dependent ID, DD Form 214 or NGB-22, as issued by the United States Department of Defense.
- A copy of a valid marriage license or certificate verifying that you are lawfully married to the military service member.
