VIII. Summary of the two requests to add grade levels to already designated schools.

Heather Sherman and Kimberly Bell shared information regarding two STEM designated schools who are requesting to add age bands.

- 1. **iSTEM** proposed to modify their current designation to expand to additional grade levels.
 - Current Enrollment 9-12 grade
 - Proposed Enrollment 6 12 grade
 - Proposed FY22 Enrollment 8 -12 grade

iSTEM is seeking approval to expand our current 9-12 grade STEM designation to include the enrollment of 6-8 grade students. iSTEM is requesting to serve grade 8 students in FY22, and expanding the enrollment to include 6 and 7 grade in FY23.

- 2. Bio-Med proposed to modify their current designation to expand to kindergarten.
 - Current Enrollment 1-12 grade
 - Proposed Enrollment kindergarten to grade 12

The Bio-Med Science Academy is seeking approval to expand our current STEM designation to include enrollment to now include Kindergarten for the 21-22 school year. The current expansion projects allowed us to increase our current footprint to know include Kindergarten. This final transition to include the youngest of learners has been recognized by the Academy's Governing Board as there is value in having an elementary program.
