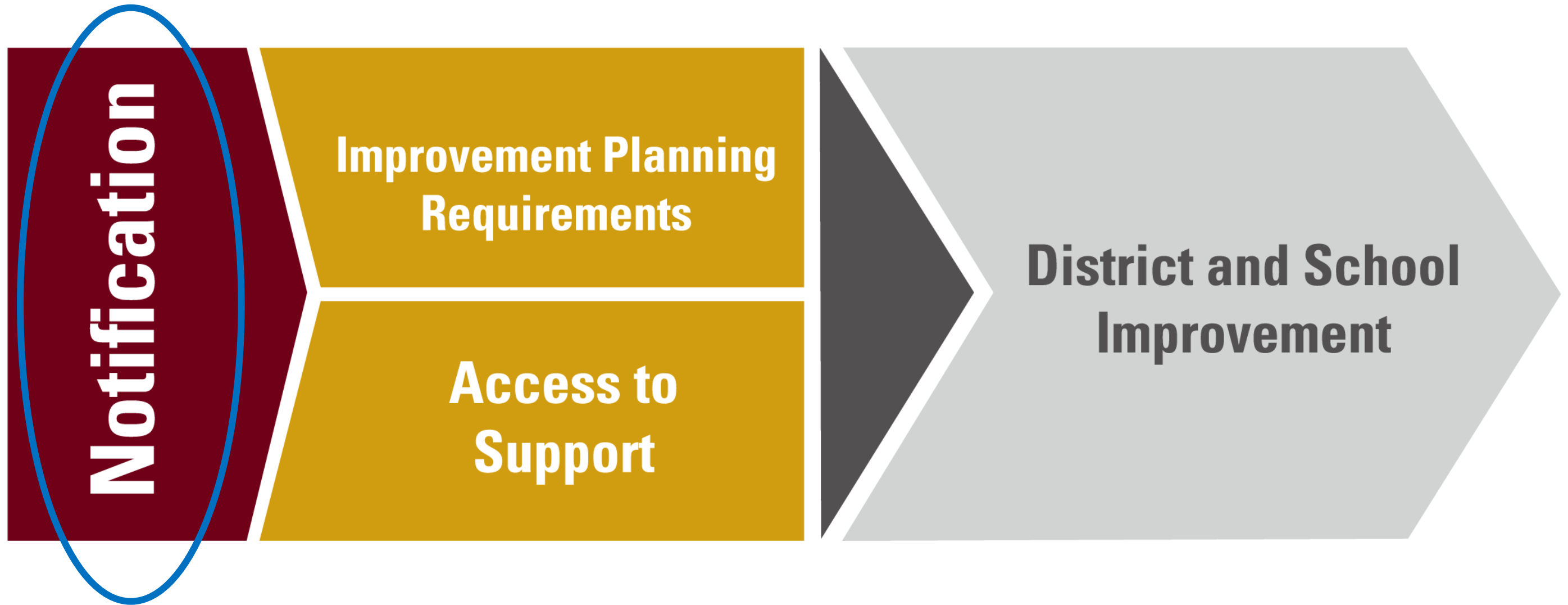

CSI Identification Process

- Lowest Performing 5%
- Low Graduation Rate
 - Equal to or less than 67%
- ATSI Schools for more than 3 years
 - Not applicable until Fall of 2025

CSI Schools - Lowest 5% - Entrance Criteria

Lowest performing 5% of schools receiving Title I funds:

- **Three or more** rated [Ohio School Report Card](#) components:
 - 95% of eligible schools
- **Two or less** rated Ohio School Report Card components:
 - 5% of eligible schools; mostly K-2 buildings

CSI Schools - Lowest 5% - Entrance Criteria

For schools with **three or more** rated report card components:

- Each Title I served school is rank ordered based on the overall rating on the Ohio School Report Card (using federal data) and the **lowest 5%** are CSI schools.
- Identified every **three years**.

CSI Schools - Lowest 5% - Entrance Criteria

For schools with **two or less** rated report card components:

- Each Title I served school is rank ordered based on chronic absenteeism percent and the **lowest 5%** are CSI schools.
 - With higher rates of chronic absenteeism designating lower performing schools.
- Identified every **three years**.

CSI Schools - Graduation Rate - Entrance Criteria

CSI schools identified based on low graduation rates:

- All public schools with a federal graduation rate **equal to or less than 67%**.
- Identified every **three years**.

CSI Schools - Lowest 5% - Exit Criteria

For CSI schools identified based on performance in the bottom 5% of schools:

1. Show **two consecutive years** of improvement above the cut score that led to their original identification,
AND
2. School performance is higher than the lowest 5 percent of schools (based on the Ohio School Report Card ratings) for **two consecutive school years**.

CSI Schools - Graduation Rate – Exit Criteria

For CSI schools identified based on graduation rate:

- The school earns a federal graduation rate better than 67 percent for **two consecutive school years.**

ATSI Schools – Entrance Criteria

Additional Targeted Support and Improvement (ATSI) Schools:

- Identification based on **subgroup performance**.
 - Federally identifiable subgroups include White, Black, Hispanic, American Indian / Native Alaskan, Asian / Pacific Islander, and Multiracial students, and Students with Disabilities, English Learners, and Economically Disadvantaged students.
- All **public schools** are eligible (excluding CSI schools).

ATSI Schools - Entrance Criteria

Additional Targeted Support and Improvement (ATSI) Schools:

- Have one or more student subgroups **performing at the same level as CSI schools** (lowest 5%) based on Ohio School Report Card data and the cut-score established by the CSI identification process.
- Identified every **three years**.

ATSI Schools - Exit Criteria

For ATSI schools, the subgroup that led to the identification of the school:

1. Must **perform higher** than the **CSI identification threshold cut score**, from the year that the school was identified as ATSI,
AND
2. Must do so for **two consecutive years**.

TSI Schools – Entrance Criteria

Targeted Support and Improvement Schools:

- **Based upon subgroup performance.**
- Identified annually from all public schools (excluding CSI and ATSI schools).
- Have one or more student subgroups performing in the **lowest 2% of schools** for a particular subgroup
- Have a **2.5 star or less overall rating** in the subgroup category for which they are identified.

TSI Schools - Exit Criteria

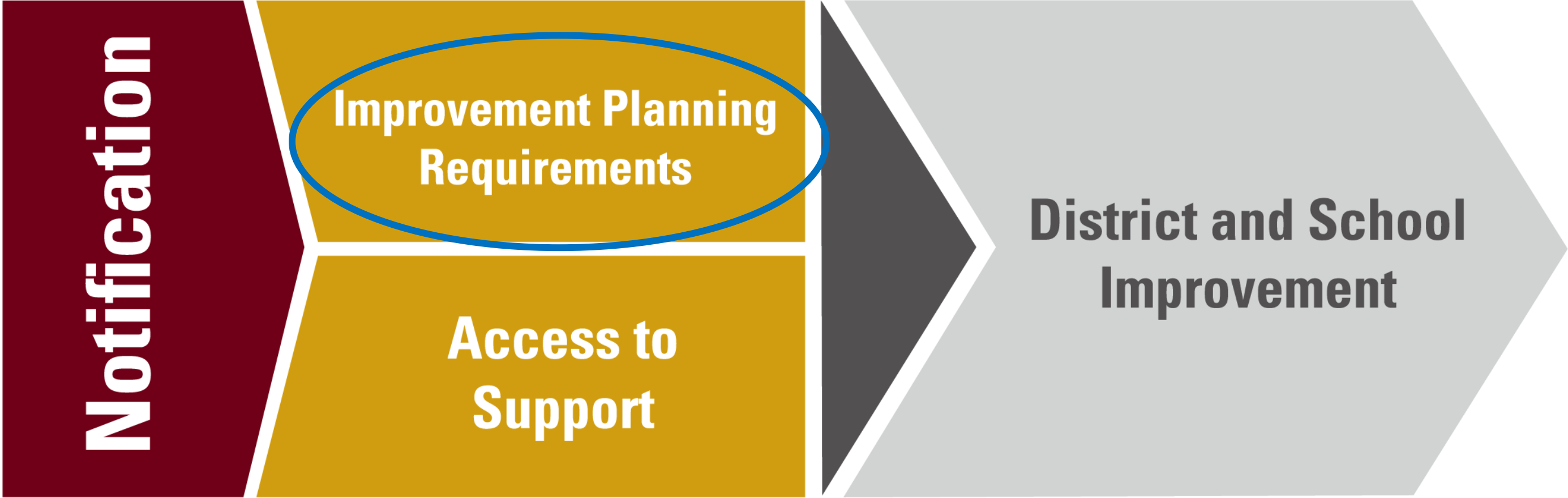
In order to exit TSI status, schools must **no longer meet** the annual identification criteria which are:

1. Have one or more student subgroups performing in the **lowest 2%** of schools for a particular **subgroup**.

AND

2. Have a **2.5 star or less** overall rating in the **subgroup** category for which they are identified.

Improvement Planning Requirements



Action Steps

All identified schools must revise One Plans

Address the reason for identification

Include evidence-based strategies

Allocate resources to fund the plan

Include All Stakeholders

Revise **One Plans** in partnership with stakeholders, for example:

- School and district leaders
- Classified staff
- Teachers
- Specialists
- Parents
- Students
- Sponsors
- Partner agency
- Community Partners

Address the Reason for Identification

- Target the **reason for identification** including report card scores or subgroup performance.
- Address the need to **improve literacy outcomes** and include activities aligned with [Ohio's Plan to Raise Literacy Achievement](#).
- Include a minimum of **two evidence-based strategies** as defined by the [Every Student Succeeds Act, 2015](#).

Allocate Resources: Fund the Plan

- Allocate **fiscal resources** to fund strategies in the revised One Plans.
- Identify **resource inequities**, which may include a review of district or school level resources.

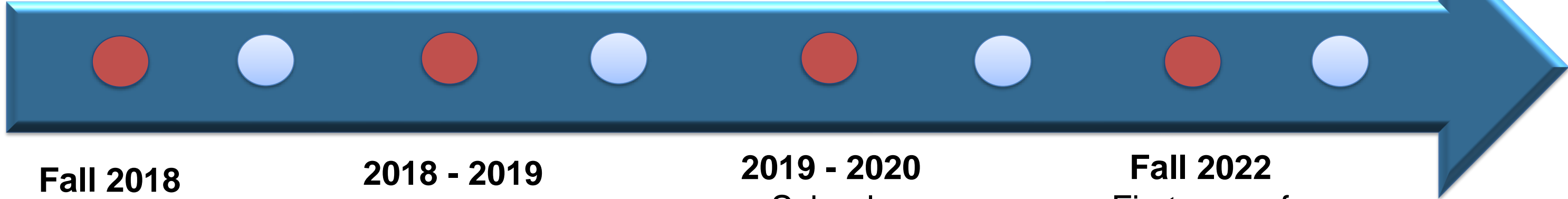

Improvement (One) Plan Timelines

Federally expected timelines for three-year Improvement / One Plan implementation.

- **Priority and Warning**

Schools Identified with 2018 data

- 2018-2019 (Planning Year)

- 2019-2020

- 2020-2021

- 2021-2022

- 2022-2023 (Federal Waiver)

- **CSI and ATSI**

Schools Identified with 2022 data

- 2023-2024

- 2024-2025

- 2025-2026

ED STEPS Cohort Alignment



- All schools in Ohio are also assigned an **ED STEPS Cohort: 1, 2 or 3.**
 - The ED STEPS planning cycle is for three years.
- When identified as **CSI, ATSI or TSI**, federal law requires that the school's improvement plan be created or updated.
- This means that, regardless of ED STEPS Cohort, these schools **must update their One Plans** to meet the requirements of identification.

Federal Guidance for Updating Plans

- The **U.S. Department of Education** gave Ohio's identified schools without submitted plans until **October 1, 2023**, to create or submit updated One Plans that meet federal guidelines.
- An **analysis** of plans from ED STEPS Cohort's 1, 2 and 3 revealed that some schools needed to submit and/or update plans.



Email Notice for Updating Plans

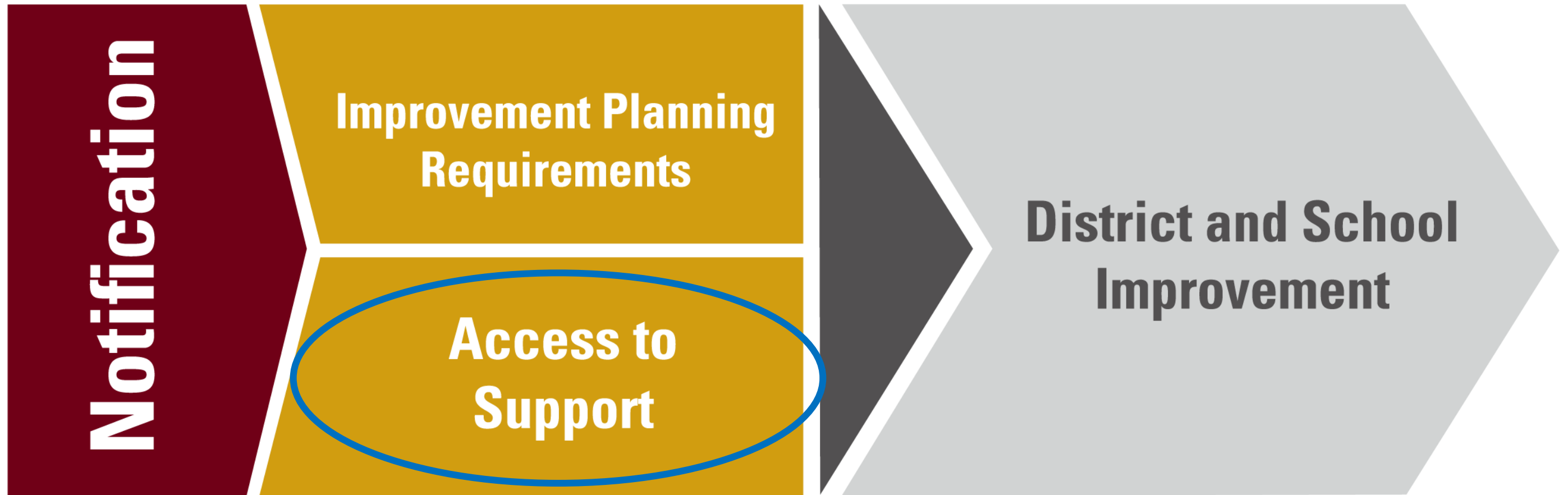
- An **email** was sent on August 14, 2023 to CSI schools that need to create or update plans.
 - **Recipients:** All contacts on original identification notice, including SST Directors.
 - **Deadline:** The October 1, 2023 deadline was shared in the message.

Guidance & Support for ED STEPS Cohorts

By October 1, 2023:

- **Cohort 1:** Create or update plan in ED STEPS or the CCIP. For the 5 schools with no previous plan in the system, a “paper plan” option was offered.
- **Cohort 2:** Create or update plan in ED STEPS or the CCIP. (A One Plan in ED STEPS is greatly preferred.)
- **Cohort 3:** Create or update plan in ED STEPS.

Monitoring Implementation: Support Schools Tool

- One Plan **mid-point** check-in.
- Used by districts and schools to track the **implementation** of One Plans.
- Required for **CSI** and **ATSI** schools.
