






METHOD: SCHOOL DATA

Which school attendance area is the site located?

This site is located in Briggs High School attendance area.





SCHOOL DATA METHOD

School data may be used to establish area eligibility, excluding camp sites

site located in a school attendance area where at least 50 percent of the children are eligible for free or reduced-price meals.

Use Elementary, Middle OR High school data

*Use any month of the most recent school year

Once established, good for 5 years

Make sure the "NSLP Provision" column says "Traditional" or "Provision 2". If it is CEP, the steps are not the same. Only use the "Percent Free and Reduced-Price Lunch" column to qualify.

This site is area eligible using the school data method! It is above 50% FRP.



SCHOOL DATA: USING COMMUNITY ELIGIBILITY PROVISION (CEP) DATA

- If using CEP data, you must check with ODE to verify
 - Individual school data must be used. Don't use district-wide CEP data.
 - Use the CEP Worksheet base year data. If you are a non-school site, work with ODE to get CEP data <u>or</u> you may choose another method for eligibility.
 - Multiply most recent Identified Student Percentage (ISP) by 1.6 factor. *If the ISP is at least 31.25, then the result will be at least 50 percent (31.25 x 1.6 = 50).




CENSUS DATA: NO KID HUNGRY MAP

- The map is color coded.
- Specific data can be checked by using NKH instructions on website or checking USDA map for adjacent census block data.

The No Kid Hungry Average Eligibility Map has been updated with FY23 data.



CENSUS DATA: USDA MAP

- Enter site address. Click the arrow to see details of the referent census block.
- Red indicates the area is <u>eligible</u>. Blue is <u>ineligible</u>.
 - *Note different color indicators on the USDA map vs. the NKH Map
- If it is blue & the FRP of either the <12 or <18 is below 40% it will <u>not</u> qualify with census data. Do not proceed with census block grouping.
- If it is blue & the FRP of either the <12 or <18 population is above 40% in the census block group or census tract, then check the adjacent census block groups to see if there is 1-2 that are at least 40% FRP in the same age category to proceed with census block grouping.

CENSUS DATA: REFERENT CENSUS BLOCK





CENSUS DATA: REFERENT CENSUS BLOCK

Neither the Census Tract or Census Block Group meets the 50% threshold.





CENSUS BLOCK GROUPING

- The site is eligible if:
 - There are 3 or fewer CBGs in the calculation including the "referent" CBG where the site or facility is located.
 - All CBGs in the calculation have at least 40% children eligible for free or reduced price meals.
 - All CBGs in the calculation are adjacent to the "referent" block group where the site/home is located.
 - The calculation uses the same age groups (0-12 or 0-18 year olds) across all CBGs.

*Always check with your state agency to confirm site eligibility



CENSUS BLOCK GROUPING

Make sure calculations are done correctly:

- Do not use weighted averages.
 - Add numerators of each CBG.
 - Add denominators of each CBG.
 - Divide the sum of numerators and sum of denominators.
- <u>Do not average the percentages</u> of free or reduced price meals in each CBG. This is only done in the final step.



CENSUS BLOCK GROUPING TEMPLATE

- ✓ Is each individual census block group is at least 40% Free & Reduced eligible based on the CBG data
- ✓ Are the data sets from all the same age group (either 0-12 or 0-18 years old)
- ✓ Did you use 3 *or less* CBG in your calculation?
