

# ARP Homeless Targeted Support Grant

## Request for Applications from eligible applicants

The Ohio Department of Education is pleased to announce a statewide funding opportunity for eligible Head Start programs, Joint Vocational School Districts, community schools and districts to support the needs of students experiencing homelessness.

Ohio is taking a multifaceted approach to help students recover from the impact of the pandemic, as evidenced by [Future Forward Ohio](#). Future Forward Ohio has three interrelated strategies: (1) overcoming obstacles to learning, (2) accelerating learning and (3) preparing students for future success. The ARP Homeless Targeted Support Grant is an important investment in **overcoming obstacles to learning**.

The ARP Homeless Targeted Support Grant's goal is to provide resources for grantees to meet the exceptional needs of students experiencing homelessness since schools and districts are a source of stability and consistency. Traditional public school districts and community schools with the full time equivalent of fewer than ten (10) identified students experiencing homelessness in the 2020-2021 school year as reported in EMIS, Head Start programs that received the Early Childhood Education Grant from the Department with access to the Comprehensive Continuous Improvement Plan (CCIP) and Joint Vocational School Districts (JVSD) are invited to apply for this grant. This is a one-time award of \$10,000 and grantees can obligate funds until June 30, 2024. Grantees can use funds to address the immediate needs of homeless children and youth and those at risk of housing instability at the local level—including identification, provisions of essential basic needs and other wraparound services and supports.

### Background

Eligible applicants can benefit from this additional funding to respond to the immediate needs of students experiencing housing instability due to the COVID-19 pandemic and create sustainable systems to identify and support students experiencing homelessness. Considerations that led to the creation of this targeted support grant include:

- **Address Likely Under-Identification:**
  - **Community Schools and Districts:** A [2021 report](#) from the National Center for Homeless Education (NCHE) estimates that 2.5% of students experience homelessness, but Ohio schools and districts report that around 1.3% of students in Ohio experience homelessness. The difference between these statistics may be due to the changes in learning models and additional barriers to regular attendance created by the pandemic. This grant is an opportunity for schools and districts to create new or revise current systems of identification for students experiencing homelessness.
  - **Head Start Programs:** A [2020 report](#) from the U.S. Department of Education found that 1 in 25 children under the age 6 in Ohio experience homelessness. This grant is an opportunity for Head Start programs to create or revise current systems of identification.
  - **Joint Vocational School Districts:** A [2020 NCHE report](#) estimates that 2.5% of students experience homelessness, but the Department reports that around 0.8% of students in JVSDs experience homelessness. This grant is an opportunity for JVSDs to create new or revise current systems of identification.
- **Improve Educational Opportunities and Outcomes:**
  - **Community Schools and Districts:** The [2021 NCHE report](#) stated that students experiencing homelessness in Ohio have low rates of proficiency in mathematics (32.1%), English (35.8%)

and science (37.1%). The [graduation rate](#) in 2020 for students experiencing homelessness in Ohio was 63.4% compared to 87.2% for housed students. This grant is an opportunity for schools and districts to encourage student success.

- **Head Start Programs:** A [2020 report](#) from the U.S. Department of Education found that Head Start programs across the state serve 6% of children experiencing homelessness. This grant is an opportunity for Head Start programs to engage students early and encourage future academic success.
- **Joint Vocational School Districts:** The [2020 NCHE report](#) states that students experiencing homelessness at JVSDs have higher graduation rates and lower dropout rates compared to traditional schools. Over the past few years, JVSDs have seen an increase in students experiencing homelessness participating in courses but a decrease in concentrations. This grant is an opportunity to ensure that students experiencing homelessness can remain in the classroom and actively engaged in their program and activities.
- **Access to Additional Funding:** Stakeholders from eligible entities have expressed that they want to improve student outcomes on these key measures and provide for the unique needs of students experiencing homelessness, but need funding and resources to do so.

## Grant Overview

Ohio's schools and districts that are eligible to apply for this grant should reference the following information throughout the application and implementation of this grant:

- This grant is funded by the American Rescue Plan as a response to the disproportionate impact of the Covid-19 pandemic on families experiencing homelessness.
- Each grantee will receive a one-time award of \$10,000 in FY 23 with automatic carryover of any remaining funds into FY 24.
- The Department intends to award funds in November 2022.
- This grant supplements existing funding streams including ARP Homeless II funding, Perkins V funding, the Early Childhood Education Grant and other state and federal sources. Grantees can use these funds in addition to other funding streams and the general fund. Grantees do not have to spend down any of these funding streams before spending down this grant.

## Purpose of Funds and Allowable Uses

These funds are available for low incidence schools and districts to accomplish one of three purposes:

1. Provide families experiencing housing insecurity with knowledge and resources to ensure educational stability and consistency for students
2. Meet essential, basic needs of students experiencing homelessness
3. Bolster existing and/or create new wrap-around services and supports.

### **Provide families experiencing housing insecurity with knowledge and resources to ensure educational stability and consistency for students**

Allowable uses for this category include:

- Summer learning opportunities and preparation for the school year
- Payment of fees to reduced barriers to attendance (including acquiring birth certificates, transferring records and immunization history)
- Professional development for personnel
- Enhancement of identification, enrollment and retention systems
- Programs and services to attract, identify and retrain students experiencing homelessness
- Training and resources to parents of students experiencing homelessness

### **Meet essential, basic needs of students experiencing homelessness**

Allowable uses for this category include:

- Referrals for medical care including dental and mental healthcare
- School supplies that can be distributed at shelters and to students directly
- Essential supplies like PPE, eyeglasses and personal care items
- Cellphones or other devices to support school participation
- High speed Wi-Fi and hotspots especially in shelters and underserved communities
- Hotel/motel stays for up to three (3) nights
- Prepaid store cards for materials to allow for participation
- Evaluation of students including special needs assessment, gifted and talented assessments and English learning assessments
- Adaption of a space outside of school to help students study
- Emergency assistance not expressly stated above

### **Bolster existing and/or create new wrap-around services and supports**

Allowable uses for this category include:

- Stipends for staff members to plan strategies, form relationships and connect with community-based organizations
- Contracts with community-based organizations to support underserved homeless populations
- Wrap-around services
- Transportation to and from school and school activities
- Early childhood education (especially for parenting students experiencing homelessness)
- The provision of services and assistance to attract, engage, and retain homeless children and youths, particularly homeless children and youths who are not enrolled in school, in public school programs and services provided to non-homeless children and youths.
- Coordination with community-based organizations to provide services and supports
- Specialized instructional services including violence prevention and counseling
- Supports and services for students living with domestic violence and parental mental health and substance abuse
- Tutoring and supplemental instruction

## **Funding Amount and Application Overview**

### **Eligible applicants and expectations**

Schools and districts with the full time equivalent of fewer than ten (10) identified students experiencing homelessness in the 2020-2021 school year reported in EMIS, Head Start programs that received the Early Childhood Education Grant from the Department with access to the Comprehensive Continuous Improvement Plan (CCIP) and Joint Vocational School Districts are eligible. Each grantee will receive \$10,000 total for fiscal

years 2023 and 2024 but may receive more depending on the number of eligible applicants. Funds must be used to support the needs of students experiencing homelessness. Grant funds may be used for indirect costs and funds can be carried over from fiscal year 2023 to fiscal year 2024. Grant funds may not be sub-granted to other entities. Grantees may draw down their funds any time between grant award and June 30, 2024. Grantees can only use funds for expenses incurred after the award of funds. Grantees will submit project cash requests (PCRs) monthly and will submit quarterly surveys to give the Department an update about how the grantees are using their funds. Grantees will be expected to participate in any evaluations conducted.

### How to apply

Schools and districts can apply for this grant by submitting the following components by October 17 at 4:59 p. m. Eastern Standard Time:

1. Answering application questions on CCIP (found in Appendix A).
2. Filling out the assurances section on CCIP (found in Appendix B).
3. Filling out a Budget and Budget Details section on CCIP (found in Appendix C).

### Scoring

Applications will have three questions and will be scored based on three criteria:

1. Does the program's proposal adhere to the allowable uses? (4 points value total),
2. Will the activities and programs included in this application support the needs of students experiencing homelessness? (4 points value total) and
3. Does this answer exceed expectations (4 points value total)

The applications with the highest scores will be awarded.

**Questions:** Applicants will be required to answer all the following questions. Applicants are encouraged to type their answers separately and then copy and paste them into the CCIP application.

1. Tell how the school, district or program will use these funds to support the needs of students experiencing homelessness.
2. What is the school, district, or program’s current identification process for students experiencing homelessness?
3. How will this grant help develop the school, district or program’s identification process, retention initiatives and educational success programs for students experiencing homelessness?

## ARP Homeless State Activities Assurances

The American Rescue Plan of 2021 (ARP-Homeless) funds are for the purposes of identifying homeless children and youth, providing wraparound services in light of the impact of the COVID-19 pandemic, and providing assistances needed to enable homeless children and youth to attend school and participate fully in school activities, including in-person instruction in the spring and summer learning and enrichment programs that begin after the typical school year. ### Eligibility Assurance

This application is for an eligible institution (a Joint Vocational School District, schools and districts with the full time equivalent of fewer than ten (10) identified students experiencing homelessness in the 2020-2021 school year as reported in EMIS or a Head Start program in Ohio that received the Early Childhood Education Grant from the Department with access to the Comprehensive Continuous Improvement Plan (CCIP)).

Applicants should budget for the entire \$10,000 grant.

Applicants will need to submit a Budget Details page which includes checking assurances (Section 1), checking requirements (section 2), answering questions (Section 3), and allowable uses allocation (Section 4). Applicants should allocate funds with the corresponding allowable uses.

Select activities that the LEA will implement with the ARP-Homeless II Funds and provide an estimated amount for that activity (check one or more). If the applicant will not spend funds on a particular use the applicant needs to enter 0.00. The allowable uses (q-w) include expanded permissions for funds due to the impact of COVID-19 and the intent to meet the extraordinary needs of student experiencing homelessness. The total in the Amount boxes must add up to the allocation.
