Executive Summary

In Ohio, there are approximately 875,000 working-age adults who do not have a high school diploma. Adults without high school diplomas are at a disadvantage when competing for Ohio's in-demand jobs. In response, the Ohio Department of Education and Workforce developed programs for adults to earn their high school diplomas. In 2014, the 22+ Adult High School Diploma program was implemented to allow adults 22 years or older to earn a high school diploma. Participants are required to complete this credit recovery competency-based program within two years. Once completed through an approved provider, the school district of residence at the time of enrollment will issue the high school diploma and transcript.

Ohio law requires the Department to report each provider's performance and publish the report on the [Department's website](#) annually. Each provider's performance is based on the following measures:

- Average number of credits earned;
- Percentage of participants completing 40% or more of credits necessary to earn a diploma during year one;
- Number and percentage of participants who earned their diplomas, withdrew, and/or returned their second year;
- Performance on state-required content assessments and other relevant work-readiness assessments.

This report is used to inform stakeholders of each provider's progress and make improvements to ensure participants successfully complete the program. Providers are required to maintain a diploma rate of 40% or higher and ensure participants complete 40% or more in credits during year one of the program. Participants who complete the required credits during year one are more likely to earn a diploma.

Key findings from this year's report include:

- The statewide diploma rate was 49%.
- Forty-nine providers met the 40% minimum provider performance level for percentage of diplomas awarded by a 22+ program based on a two-year cohort.
- Seventy-six percent of participants completed 40% or more of their credits necessary to earn a diploma in year one statewide.
- In the 2023-2024 school year, 3,112 participants enrolled in 22+ programs.
- On average, participants had earned 18 credits prior to enrollment and needed to pass one state graduation test.

Ohio is committed to offering programs for adults to earn their high school diplomas. This report provides stakeholders with the necessary data regarding the performance measures of the 22+ Adult High School Diploma Program.

Introduction

Ohio law¹ allows adults ages 22 and over a credit recovery opportunity leading to a high school diploma. Adult learners need to only meet the minimum graduation requirements from the year the student initially entered ninth grade. The program is free to adults who are at least 22 years old, live in Ohio, and do not have a high school diploma or certificate of high school equivalence.

Educational institutions eligible to offer the 22+ Adult High School Diploma include:

- Community schools that operate dropout prevention and recovery programs;
- City, local, or exempted village school districts that operate dropout prevention and recovery programs;
- Joint vocational school districts that operate adult education programs;
- Community colleges, university branches, technical colleges, or state community colleges.

Participant Overview

In the 2023-2024 school year, 3,112 participants enrolled in the program. The average age of participants was 34 years old, and the highest grade completed was 12th grade. Table 1 identifies participant percentages of race/ethnicity and language spoken.

Ohio Administrative Code Sections 3301-45-01 through 3301-45-10 govern the operations of the 22+ Adult High School Diploma Program and were sanctioned by the mandates included in Ohio Revised Code Sections 3301.07, 3314.38, 3317.01, 3317.036, 3317.23, 3317.231, 3317.24, and 3345.86.

Fiscal Year 2024 Student and Provider Performance Data

PERCENTAGE OF DIPLOMAS AWARDED

Effective July 1, 2016, [Ohio Administrative Code 3301-45-06 \(E\)](#) required the State Board of Education to establish a minimum provider performance level for percentage of diplomas awarded (diploma rate).

The State Board of Education adopted a 40% minimum provider performance level for percentage of diplomas awarded by a 22+ program based on a two-year cohort that is lagged one year.

MEASURE DESCRIPTION:

Generally, Ohio Revised Code [3314.38](#), [3317.23](#), [3317.24](#),² and [3345.86](#) allow for a student to have up to two consecutive school years to earn a diploma. To account for this, the percentage of diplomas awarded is a cohort award rate of two years.

To calculate the minimum performance level for percentage of diplomas awarded, the Department tracks the success of students over two fiscal years. The denominator (cohort) includes any student who was accepted into the program for the first time in the fiscal year, regardless of whether the student withdrew, did not proceed with the program, or graduated in that fiscal year. The numerator is any student from the cohort who earned a diploma in that fiscal year or the next consecutive fiscal year.

TECHNICAL CALCULATION:

- **Denominator:** The denominator, or cohort, is created by determining those students who are entering the program for the first time for that fiscal year (Application Types = “New”). In addition, those students must have been accepted into the program (Status = “Accepted,” “Terminated,” or “Requirements Passed”).
- **Numerator:** The numerator includes:
 - For the first fiscal year, students from the cohort who have the application type “New” and status “Requirements Passed.”
 - For the second fiscal year, students from the cohort who have the application type “Renew” and status “Requirements Passed.”

The diploma rate is calculated by fiscal year as described above. It is important to note that as participants have two years to complete their requirements, the final diploma rate is lagged one year. The FY23 diploma rate includes participant information from 2022-2023 and 2023-2024. This report includes the final diploma rate for FY23.

² In the case of joint vocational school districts, the law allows for two cumulative years.

DIPLOMA RATE CALCULATION EXAMPLE FOR FY23:

DIPLOMA RATE CALCULATION FOR FY23 RATE:

Fiscal Year 2023 had 2,044 first-time students accepted into the program. There were 643 students who met the requirements, and 1,401 were eligible to return to the program in 2024.

In FY24, 898 of the remaining 1,401 students renewed — 503 (64.1%) students either dropped out or never renewed. Of those 1,401 students, 357 met requirements in 2024.

Diploma Rate by Provider

One-Year Credit Completion Rate

MEASURE DESCRIPTION:

The one-year credit completion rate is a measure reported at the provider level. To calculate the one-year credit completion rate, the Department tracks the credits earned by students over one fiscal year. At the beginning of the program, each student establishes the number of credits they need to earn a diploma. The first calculation determines the completion rate at the individual student level by taking the number of credits completed divided by the number of credits needed to earn a diploma. The one-year credit completion rate at the provider level is then created by calculating the number of students in the cohort at each provider divided by the students who met

the 40% threshold established in rule.³

The rate does not include those participants who only need to pass assessments, as it focuses solely on credit completion.

TECHNICAL CALCULATION:

- **Denominator:** The denominator is created by determining those students who are entering the program for the first time for that given fiscal year (Application Types = “New”).
- **Numerator:** The numerator includes:
 - Students from the cohort who have the application type “New” and met the threshold of completing 40% of credit hours required (reported in “Plan to Complete”).

One-Year Completion Rate for 2024 Cohort

The table below shows the percentage of participants completing 40% or more of their credits necessary to earn a diploma. As the diploma awarded rate captures two years of data as noted above, this completion rate provides a snapshot of performance for the 2024 cohort.

Average Credits Earned Per Student

The average credits earned per student varies, as students can enter the program needing up to 15 credits. Other students may have earned all the credits needed and only need to pass the Ohio Graduation Tests (OGT) at the time of enrollment. On average, new students earned 18 credits prior to enrollment. On average, each student needed to pass one state graduation test. The table below provides the average credits earned by all students participating in the program during the 2023-2024 school year — regardless of cohort assignment. Data includes students in year one and year two of the program. To calculate the average credits earned per student, the total number of credits completed by all students is divided by the number of students participating.
