Student Assessment Inventory

BACKGROUND

In January 2021, Ohio's Auditor of State issued its <u>Performance Audit</u> for the Ohio Department of Education. This performance audit recognizes that standardized student assessments are valuable tools for learning and measuring academic growth and achievement. It notes that districts use assessments for a variety of purposes, beyond simply meeting state and federal requirements. Tests inform schools about student progress and, when needed, indicate when they should provide additional student support. The results of assessment also help guide and strengthen future teaching

through additional training and changes to curriculum. The audit, however, also acknowledges concerns—from the public, educators and parents--that there may be too much testing.

INVENTORY TOOL

The assessment inventory is intended to help schools or districts take a comprehensive look at their student assessment systems—should they choose to use this optional tool.

Conducting an inventory of assessments currently in place can spur deeper discussion to

- build a shared understanding of the purpose of each assessment
- point out gaps or redundancies
- highlight which assessments provide actionable information and data
- > streamline or strengthen the assessment program
- assist in planning a coherent assessment strategy

Optional Inventory

This resource can be used by school and district administrators to consider assessments being used, reflect on why they are being used, and review what data is collected from their use.

This inventory tool can be one part of a thoughtful process to consider the effectiveness and efficiency of local assessment systems.

TIME SPENT ON ASSESSMENTS

The assessment inventory tool can also be used by districts to check compliance with statutory requirements on the amount of time students spend on testing. With some exceptions, Ohio Revised Code 3301.0729 requires that local boards of education ensure that students are not required to spend

- more than two percent of the school year taking the state-required assessments combined with locally determined assessments administered districtwide or
- more than one percent of the school year taking practice or diagnostic assessments used to prepare for the state-required assessments or locally determined assessments administered districtwide.

APPENDIX A. OPTIONAL ASSESSMENT INVENTORY TOOL

Optional Student Assessment Inventory Tool

This inventory provides some suggested questions and data to gather. Add to these or modify them to suit the purposes intended by an assessment inventory in the school or district.

It is recommended that the school or district convene a team to work through the inventory process. The steps the process can take include 1) reflecting and planning, 2) conducting the inventory, 3) analyzing the inventory, 4) making recommendations for changes, if needed, and 5) evaluating the outcome of those changes, if any. Schools and districts can regularly reexamine their assessments considering such factors as local context and needs and changing statute and requirements.
